Waiver of Liability - Assumption of Risk: I do hereby release and discharge the sponsors, Arkansasrunner.com, directors, coordinators, assistants, volunteers, CASA of Clark and Pike Counties, and City of Arkadelphia, whether compensated or uncompensated, of any and all liability arising from illness, injuries and damages I may suffer as a result of my participation in this event. This waiver of liability and assumptions of risk specifically includes any liability resulting from (1) Availability of inadequacy of aid stations; (2) Availability or inadequacy of traffic controls; (3) Failure to warn of hazards on the course; (4) Failure to provide adequate pick up crews who assist runners who are lost or develop difficulties, (5) Failure to provide or inadequacy of medical support facilities. I further state that I am in proper physical condition to participate in this event and suffer from no medical conditions, which would put me at risk, injury of death that may occur as a result of any condition of my participation in this event. I am participating in this event as a recreational event, in which I will maintain a safe outlook at all times and assume the risk for any traffic or hazards during the race.
